Ongoing Diplomacy: Joint Working Group on Palm Oil

between ASEAN and the European Union

- Outcome of the 23rd Ministerial Meeting between ASEAN and the EU, December 2020
- The First Joint Working Group held on 27 January 2021
- Objective: a platform to discuss and sharing views about sustainability aspect of vegetable oils sector

Key take away:



Agreement between the parties on knowledge sharing, technical cooperation and capacity building, and joint webinar about sustainable vegetable oils.



The on-going process in the JWG will not replace the Dispute Settlement in WTO (DS593)



The parties agreed to hold a Second Joint Working Group on 19 April 2021 with Malaysia as *co-chairs* alongside the EU

Ongoing Diplomacy:

Update on the Preparation for FAO –Intergovernmental Group Meeting on Oilseeds, Oils, and Fats (IGG- OOF): Formulation of the Voluntary Guidelines on Sustainable Vegetable Oils in Support of SDGs

- **The IGG OOF is a unique and fitting platform** to discuss current trend and prospective of vegetable oils and oilseeds markets
- Opportunity **to develop a guideline on sustainable vegetable oils** that will contribute to the achievement of the SDGs
- To **highlight opportunities and challenges** for improving sustainable production systems among vegetable oil producers
- An **opportune moment** as the last IGG OOF(30th Session) was convened in 2009

OBJECTIVES OF THE FORMULATION OF VOLUNTARY GUIDELINES ON SUSTAINABLE VEGETABLE OILS IN SUPPORT OF SDGs (VG-VSO)

- Set up VG-VSO that embrace the sustainable cultivation of oil seeds and the production and processing of vegetable oils
- The proposed structure of the VG-VSO will include, among others, an overview of relevant sustainability issues related to vegetable oil production and consumption, including their opportunities and challenges in SDGs in Agenda 2030 for Sustainable Development
- Include recommendations for improving the sustainable management of vegetable oils based on the three pillars of sustainable development namely economic, social and environment
- Ensure unity of purpose in addressing and setting out a path to meeting Agenda 2030 and its Sustainable Development Goals
- Contribute towards a better mutual understanding of the sustainability criteria that balance out economic and social progress with the environment, and include existing standards and certification of vegetable oils

31st IGG OOF

Timeline and Progress

72nd Session of Committee of Commodity Problems (CCP), 26-28 Sept 2018

- Indonesia conveyed the proposal to formulate voluntary guidelines on sustainable vegetable oils in support of the SDGs
- The Committee took note of proposal to convene IGG OOF to discuss the VG-VSO proposal

CCP Bureau Meeting, 22 December 2020

Agreed on tentative agenda items and proposed panelists for the IGG OOF

Correspondence of DG FAO, Minister of Foreign Affairs of Indonesia, and Ambassador of Indonesia in Rome, January 2021
→ unequivocal support for Indonesia and FAO to co-host IGG OOF

31st Session of IGG OOF, 4-5 March 2021

Hybrid format, include panel discussion with experts on sustainable vegetable oils in support of SDGs (invitation will be sent out soon)

74th Session FAO Committee on Commodity Problems (CCP) 10-12 March 2021 → The result of the discussion on the VG-VSO during the IGG OOF will be reported to FAO CCP for further consideration.

UK importers are required to take environmental and human right risks assessment of the commodities' supply chain, take precaution and risk mitigations, and report to the UK Government



Indonesia will advocate for the UK Government to apply the same standard for like and similar products; to address sustainability in a holistic and non-discriminatory manner; and to have a balanced approach between the 3 pillars of SDGs



Various sustainability standards and certifications applied for palm oil exist today



Indonesia and the UK will hold a *joint working group* to promote seamless two way sustainable trade → Indonesia will push for a mutual recognition agreement

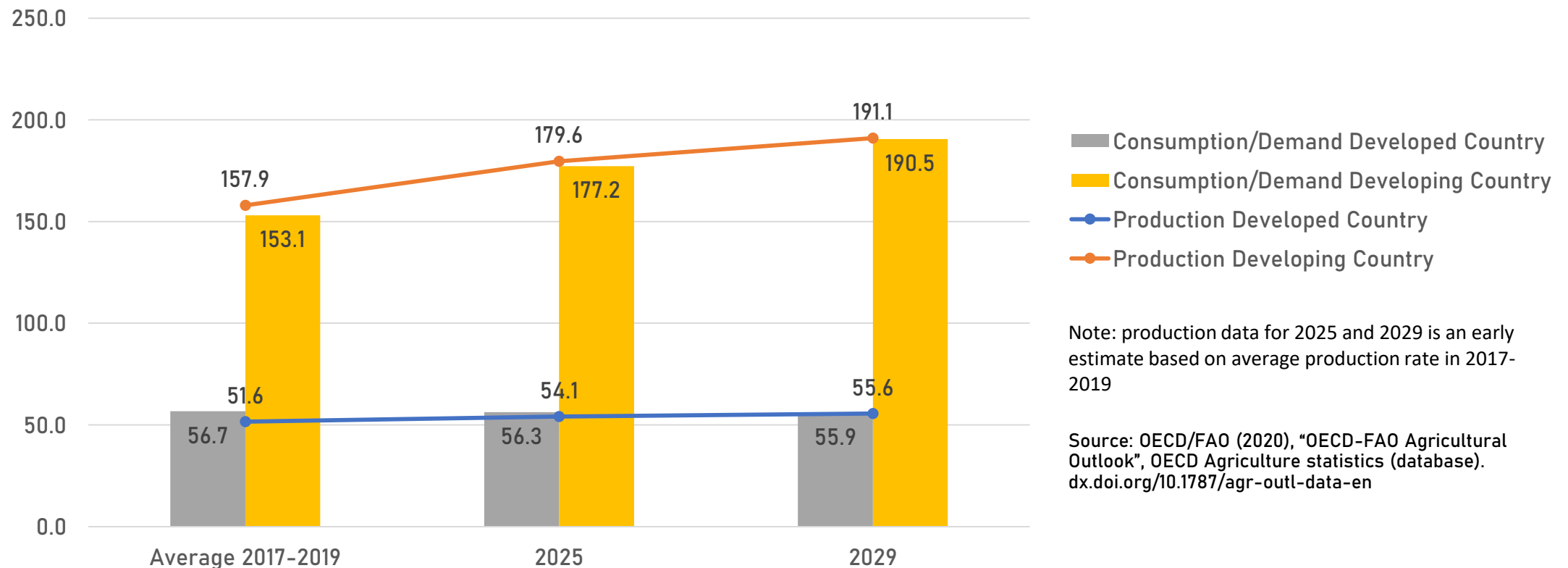
The Way Forward: Narrative

- **Non-discrimination treatment of vegetable oils and putting all vegetable oils at the same par**
- **Using the SDGs as the main benchmark for sustainability**
 - **This implies a holistic and balance account on economic, social and environmental dimensions in overviewing all vegetable oils**
- **The important role of all vegetable oils, including palm oil, to fulfill the global demand of vegetable oils in the future**

The Way Forward:

Synergy Research & Diplomacy

- Mainstreaming nexus between vegetable oils & SDGs as a common narrative for all stakeholders
- Non-discriminatory standards & treatment among vegetable oils
- More in-depth research & funding for research on vegetable oils
- Inclusive process in determining vegetable oils standards → producer & importing countries, farmers & consumers
- Synergy bilateral, regional & multilateral forums → private & public
- Partnership & joint collaboration for research & diplomacy with all stakeholders (e.g. academics, researchers, think tanks, politicians, private sector & farmers)
